Neuro Course for Stroke Management

Course Overview

Neuroradiology will be offering a CME accredited course for physicians interested in training in the management of acute stroke. The course will focus on the role of CTA in the diagnosis and treatment of acute stroke. Specifically - the benefit of the newer "whole brain" volume scan method in the evaluation of acute stroke. Physicians from Neuroradiology and Neurosurgery will be working together to offer the three day course throughout the year.

Addendums

AquilionOne

With the AquilionONE volume scanner, we now have the ability to evaluate perfusion not only of the brain, but also tumors and organs of the body. In the coming months, Dr Roger Shifrin (Clinical Assistant Professor) will be using this perfusion CT protocol to study angiogenesis in non- small cell lung cancer correlated with histologic microvessel density and genetic markers of angiogenesis. Dr Jim Caridi (Associate Professor and Chief) will use this new technology to evaluate liver tumors following RF ablation and embolization procedures. Drs Anthony Mancuso (Professor and Chairman) and Sharatchandra Bidari (Post-doctoral Associate) will be studying head and neck cancer to assess therapeutic response.

Division Updates

Neuroradiology

3T Advanced Imaging

Dr Jeff Bennett (Assistant Professor) is working closely with Drs Clark Diffendaffer and John Murray (Fellows), and the MRI Techs to implement 3T advanced imaging - including brain tumor perfusion, and diffusion tensor imaging of neoplastic, developmental, and degenerative processes.

Spine Interventional Radiology

Procedures

The Spine Interventional Radiology group performed its first intercostal nerve block and its first CT-guided sacroplasty in November. Both procedures were successful and resulted in dramatic pain reduction.

Vascular and Interventional Radiology

Irreversible Electroporation

The Vascular and Interventional Radiology division recently placed a purchase order for Irreversible Electroporation - which is a minimally invasive means of eliminating small tumors. There are only a few sites in the United States with this technology and less than 100 patients have been treated worldwide. Since this technology is in its infancy, we hope to be instrumental in its development for the treatment of metastatic and primary cancer.

Infirmiry (SHCC) Report Turn-around Times

The Community Group is exploring scheduling and report turn-around times for any additional study that a student might need (US, CT, MRI). Currently, the SHCC send students to outside imaging services due to ease of scheduling and rapid turn-around times. Our goal is to secure those services by efficiently scheduling and processing of reports.

The C-arm is up and running at Starke for OR Cholangiograms. Thanks to all involved.

Equipment

Lake Shore will have a digital mammography unit, stereo, and ultrasound mammatome system installed in the near future. Location and logistics are currently under review.

Breast Lymphoscintigraphy

Lake Shore has begun breast lymphoscintigraphies for palpable, proven cancers. The first needle loc(s) are scheduled in January.

ADMINISTRATION

W-2 Forms

Distribution

2009 W-2 forms will no longer be distributed by the departments as a result of the implementation of electronic W-2 forms.

In accordance with IRS regulations, employees' 2009 W-2 forms will be mailed by January 31, 2010 to employees who do not consent to receive their W-2 forms electronically. The printed W-2s will be mailed to the employees' local home address in the Directory. ***Each employee is responsible for maintaining current Directory information.***

For employees who consent to receive their W-2 electronically: The electronic 2009 W-2 forms will be available at least one week earlier than the mailed forms; Communication will be sent to the employees' UF e-mail address when the electronic W-2s become available; and Employees consenting to receive their 2009 W-2 forms electronically by Friday, January 15 will not receive a paper 2009 W-2 form via U.S. mail.

Year-End Earnings Statements

Update

Employees will be provided Employee Year-End Earnings Statements which will assist them in comparing the amounts on the 2009 W-2 form to the earnings, deductions, taxes and net pay on their last biweekly earnings statement for 2009.

This year's Employee Year-End Earnings Statements will only be available electronically through [my.ufl.edu/My Self Service](http://my.ufl.edu/MySelfService). Employee consent is not required for an employee to have access to the Employee Year-End Earnings Statements. Foreign national employees or nonresident aliens will receive their IRS 1042-S forms on or before March 15, 2010 since these employees have special withholding and reporting requirements with the IRS. Nonresident aliens receiving IRS 1042-S forms will not receive Employee Year-End Earnings Statements.
